The Cooperative Republic of Guyana has received financing from the Inter-American Development Bank (IDB), toward the cost of the *Support for the Implementation of the Citizen Security Strategy (ATN/OC-14259-GY)*, and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") include the design of an integrated results-based M&E framework for the Ministry of Public Security, Guyana Police Force, Guyana Prison Service and Guyana Fire Service; establishment of an M&E information system; and building the capacity of staff in monitoring, evaluation and data analysis.

The Ministry of Public Security now invites eligible **consulting firms** ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

The short list shall comprise six firms with a wide geographic spread, with no more than two firms from any one country.

Consultants will be selected in accordance with the procedures set out in the Inter-American Development Bank: [\*Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank\*](#) GN-2350-9 and is open to all eligible bidders as defined in the policies.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. For the purpose of establishing the short list, the nationality of a firm is that of the country in which it is legally incorporated or constituted and in the case of Joint Venture, the nationality of the firm appointed to represent it.

A Consultant will be selected in accordance with the **Quality and Cost Based Selection (QCBS)** method set out in the Consultant Policies.
