CARPHA's mission is to provide strategic direction, in analysing, defining and responding to public health priorities of Member States, in order to prevent disease, promote health and to respond to public health emergencies. This allows CARPHA to support solidarity in health, as one of the principal pillars of functional cooperation, in the Caribbean Community. CARPHA is currently serving as the Executing Agency for the 11 <sup>th</sup> European Development fund (EDF) Programme of Support for Health Security Strengthening for Prevention and Control of Outbreaks of Communicable Diseases in the Caribbean. The Epidemiologist, Tourism and Health Programme (THP) will support the achievement of the objectives of the 11 <sup>th</sup> EDF Programme of Support for Health Security Strengthening for Prevention and Control of Outbreaks of Communicable Diseases in the Caribbean. Under the supervision of the Head, Tourism and Health Program, the incumbent will provide oversight for implementing the Tourism and Health Information System in the highlighted CARPHA Member States, supporting the full integration of this visitor-based system into the existing national surveillance systems. This incumbent will also provide technical input in the continued development of the Caribbean Traveller's Health Assurance Stamp and the Caribbean Traveller's Health Mobile Application. Results of technical work in this area aids in the monitoring of health status and its correlation, identification of trends or disease outbreaks or other adverse health events and providing data and information about corrective actions or programs to promote and protect public health.
