10 Submission of tenders

10.1 The CARICOM Secretariat must receive the tenders before the deadline specified in 10.2. They must include all the documents specified in point 11 of these Instructions and be delivered either by post of hand to the following address

10.2 All tenders must be submitted in one envelope, marked 'original', and four copies signed in the same way as the original and marked 'copy'.

Tenderers shall seal the original and each copy of the bid in an inner and outer envelope, duly marking the envelopes as "original" and "copy".

The inner and other envelopes shall be addressed to:

- b) Bear the name "Application of Moisture Barrier Sealant and Epoxy Resin to Office Quadrants floor Space at the CARICOM Secretariat" and the words "DO NOT OPEN"
- 10.3 All tenders must be received at **TENDER BOX 1, CARICOM Secretariat, Turkeyen Greater Georgetown, Guyana** before the deadline date and time, **5 June 2025 at 10:00 a.m. Guyana time**), by registered letter with acknowledgement of receipt or handdelivered against receipt signed by its representative.
- 10.4 All tenders, including annexes and all supporting documents, must be submitted in a sealed envelope bearing only:
 - **a**) the above address;
 - b) the reference number of this tender procedure, (i.e. CCS/Q1-Q8/ASU/2025);
 - c) where applicable, the number of the lot(s) tendered for;
 - d) the words 'Not to be opened before the tender opening session' in the language of the tender document .
 - e) the name of the tenderer.

The technical and financial offers must be placed together in a sealed envelope. The envelope should then be placed in another single sealed envelope/package, unless their volume requires a separate submission for each lot.

- 14 Clarification meeting / site visit
- 14.1 A clarification meeting / site visit will be held on 24 April 2025 at 10:00 a.m. (Guyana time) CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana to answer any questions on the tender document, which have forwarded in writing or are raised at the meeting. Minutes will be taken during the meeting and these will be published on the CARICOM Secretariat's website together with any clarifications in response to written requests which are not addressed during the meeting at the latest 11 calendar days before the deadline for submission of tenders. No further clarification will be provided after this date. All the costs of attending this meeting will be borne by the tenderers.

19 Opening of tenders

19.1 The purpose of the opening session is to check whether the tenders are complete, whether the required documents have been properly included and whether the tenders are generally in order.

19.2 The tenders will be opened on <u>5 June 2025 at 11:00 a.m. Guyana time</u> at the CARICOM Secretariat, Turkeyen Greater Georgetown, Guyana by the appointed committee. The committee will draw up minutes of the meeting, which will be available on request. All bids will be opened in the presence of those tenderers' representatives who may choose to attend. The tenderers' representatives who are present shall sign a register evidencing their attendance. The Secretariat reserves the right to vary this date, depending on the exigencies of Procurement Department.
