# CONSULTANCY SERVICES TO DESIGN A SOCIAL PROTECTION TOOLKIT FOR THE OECS REGION

The Organisation of Eastern Caribbean States (OECS) Commission invites interested eligible Individual Consultants to submit Expressions of Interest for the provision of consultancy services to design a toolkit to strengthen social protection systems to be integrated, comprehensive, and adaptable to shocks as well as enabling progressive universal coverage in the OECS Region.

The Terms of Reference and Guidelines for the Submission of Expressions of Interest for this consultancy are provided below.

#### 1.0 BACKGROUND AND INTRODUCTION

The Organization of Eastern Caribbean States (OECS) Commission serves eleven Member States: seven full and six associate member states. Of these numbers six are independent nations: Antigua and Barbuda, Dominica, Grenada, St Kitts and Nevis, St Lucia and St Vincent and the Grenadines; three are British Overseas Territories: Anguilla, British Virgin Islands and Montserrat; and two are French Overseas Territories: Martinique and Guadeloupe. Together the stated islands are home to an estimated population of 1,509,721 inhabitants; 30% of which are children (individuals aged 0-17 years), 24% are youth (individuals aged 15 to 29 years) and 13% are older persons (aged 60 and above). This means that over 64% (including single female headed households) can be categorised as vulnerable to poverty, shocks, and social exclusion. Such a situation combined with their high vulnerability and exposure to climate hazards (IPCC, 2018) such as tropical storms, hurricanes, sea level rise, ocean acidification, and changing patterns of precipitation; high debt to GDP ratio, and small mono-economies, makes it imperative that member states establish robust and comprehensive social protection policies and programmes.




Figure 1: Types of social protection coverage

Social protection is the 'set of policies and programmes aimed at preventing or protecting all people against poverty, vulnerability and social exclusion throughout their lifecycle, with an emphasis towards vulnerable groups', as defined by the Inter-Agency Social Protection Assessment (ISPA) Initiative. These instruments take the form of contributory and non-contributory schemes/programmes and labour market policies and interventions (see Figure 1). They serve to mitigate against life cycle risks and other external shocks and enable economic development by increasing the number of persons participating in the workforce and enhancing social stability. Therefore, the adaptiveness, sustainability and comprehensiveness of these policies and programmes become ever more important in times of humanitarian crisis, during which the number of persons in need may increase exponentially overnight.

To assist Member States in increasing the social resilience of their populations, the OECS Commission and UNICEF Eastern Caribbean are collaborating to help develop technical tools and capacities to formulate, implement and manage robust and comprehensive social protection

policies and programmes which serve those who need support both outside of and during/after a humanitarian crisis.

#### 2.0 **OBJECTIVE**

The purpose of this Consultancy is to design a toolkit as part of a capacity building process to provide policy-makers and practitioners in the Eastern Caribbean with the technical tools and capacities needed to strengthen social protection systems that are progressively universal, child-sensitive and shock-responsive. Guided by the Convention on the Rights of the Child (CRC), Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW), Grand Bargain principles, the Agenda 2030 and its Sustainable Development Goals (SDGs), international agreements and guiding frameworks, the toolkit does not aim to repeat existing global and regional guidance and toolkits, but will guide its users towards such resources as a "one-stop shop" for technical assistance on social protection.

The purpose of this toolkit is threefold:

- 1) To make practical guidance available to policy-makers and practitioners in a user-friendly way on how to assess, design, implement, and monitor social protection programmes and systems, including in contexts of crises (**one-stop shop**);
- 2) To accompany the transition from Social Policy Framework to OECS Social Inclusion and Social Protection Strategy/Framework by providing a **regional lens** to existing resources —and evolving as countries/territories move forward in implementation;
- 3) To provide a platform for peer-to-peer exchanges and a **capacity building process** for and with OECS Member States.

The tool is expected to comprise guidance - incorporating already existing resources – supported by short briefs, checklists, assessment tools, templates (e.g. ToRs, job descriptions of key social protection functions) and study cases, to provide options for consideration, for the following components, but not limited to:

- 1. Evidence to inform programmes and policies including child poverty and vulnerability analyses, systems, and programme assessments, monitoring and evaluations.
- 2. Policy, legislative and financing frameworks for social protection and coordination mechanisms or integration of services.
- 3. Programmes design, coordination and harmonization including social assistance, social insurance, labour market programmes and the social service workforce.
- 4. Administrative mechanisms and tools such as programme beneficiary registries or social registries, payment mechanisms and feedback mechanisms.

#### 3.0 SCOPE OF SERVICES

Under the guidance of the Head, Social Development Unit, OECS Commission, the Consultant will be required to:

- 1. Review relevant global and regional guidance and toolkits regarding their usefulness for the purpose of a regional OECS toolkit (including but not limited to: the ISPA tools, TRANSFORM methodology incl. on shock-responsive social protection/SRSP, OPM SRSP toolkit, European Commission's Tools and Methods Reference Doc. 26, ODI guidance on gender sensitivity, UNICEF child-sensitivity toolkit, Social Protection toolbox, and the existing OECS Social Policy for Children's Rights toolkit with relevant and up-to-date data and information).
- 2. Develop the toolkit's learning methodology building on existing resources and draft missing elements as needed to guide the user to (max. 10-page) short guidance briefs with checklists, assessment tools, templates (e.g. for ToRs, job descriptions of key social protection functions), supported by study cases (incl. audio-visual material);
- 3. Organize a series of consultations and exchange opportunities with Member States around the different topics of the toolkit throughout the development process;
- 4. Work with a web developer to make this content available through an updated website
- 5. Map all existing social assistance and social care programmes, evidence on poverty and assessment analysis, existing active policies, legislation, and strategies at the national, regional and international levels based on existing OECS and Member States' inputs and develop an approach for the OECS to regularly update this information (bi)annually.

- 6. Build on the *Social Policy for Children's Rights Toolkit* modules to include specific themes on child responsive broader themes social protection policy development, implementation, and management.
- 7. Develop a section on social assistance and social care programme development, implementation, and management for inclusion in the updated toolkit.
- 8. Design a section on social protection programme development, implementation, and management to prepare for and respond to shocks, such as natural disasters, economic and global pandemic/health crises.

#### 4.0 DURATION OF THE ASSIGNMENT

The assignment is expected to be undertaken in 60 days within a 4-month period. This assignment will be undertaken during the period November 2021-March 2022. The Consultant shall:

- 1. take all the necessary steps to ensure that the entrusted task is executed properly and on schedule in accordance with the established Terms of Reference.
- 2. undertake to perform the task in accordance with the Terms of Reference and according to internationally accepted standards.

# 5.0 REPORTING AND KEY OUTPUTS/DELIVERABLES/TIMELINES

#### 6.0 INSTITUTIONAL AND IMPLEMENTATION ARRANGEMENTS

The Social Development Unit (SDU) will be the coordinating agency on behalf of the OECS Commission. The Consultant will work under the direction of Head, Social Development Unit of the OECS Commission.

Technical Assistance will be executed through the Programme Officer, Human and Social Cluster, with the support from the UNICEF Social Policy Manager and Social Policy Specialist.

A National Focal Point from each Member State will assist in coordinating arrangements for key informant interviews and focus group meetings.

## 7.0 QUALIFICATIONS AND EXPERIENCE

The Consultant shall possess:

- 1. At least a Post-Graduate/Master's Degree in Social Policy, Social Work, Development Studies, or another related field;
- 2. At least seven (7) years experience in the Social Policy, Social Protection policy or programme design, implementation and monitoring;
- 3. Proven knowledge of international standards, tools and good practices in social protection;
- 4. Experience in conducting reviews of technical, subject-specific education material on social protection policy and programme design, implementation and management.
- 5. Proven experience in building the capacity of individuals in social policy and programme development, implementation, and management at the institutional level.
- Experience in developing online learning material and course work, including the design
  and presentation of technical material to a mixed audience in a very clear and concise
  manner.
- 7. At least one successfully completed similar assignments during the past five (5) years.
- 8. Experience in undertaking social protection work in the Caribbean/ OECS Region would be an advantage.
