The Government of Guyana has requested financing from the Inter-American Development Bank (IDB) and the Japan International Cooperation Agency (JICA) for the **Guyana Climate Resilient Water Infrastructure Improvement Program (GCRWIIP)** and intends to apply part of the funds to contracts for consulting services. The consulting services (“the Services”) include the **design review and supervision of the construction of a 26MLD Water Treatment Plant as well as the installation of transmission mains.**

The Guyana Water Inc. invites eligible Consulting Firms to express their interest in providing the requested Services. The shortlist must include a minimum of five (5) and a maximum of eight (8) eligible firms.

The selection of consultants will be conducted in accordance with the procedures set forth in the Policies for the Selection and Contracting of Consultants Financed by the Inter-American Development Bank, GN-2350-15. Participation is open to firms from eligible countries, as specified in these Policies.

Consulting firms may associate with other firms in the form of a **Joint Venture** or may engage **subconsultants** to enhance their qualifications. For the purpose of establishing the **shortlist**, the nationality of a firm shall be determined by the country in which it is legally incorporated. In the case of a **Joint Venture**, the nationality of the firm appointed as the representative shall apply. Consultants will be selected using the **Quality Cost Based Selection Method** outlined in the **Consulting Policies**.

Interested consultants may obtain further information by sending an inquiry via email or visiting the address provided at the end of this notice, between 8:00-16:30 hours (Guyana time) Monday to Friday.

Expressions of Interest must be submitted in two hard copies and one electronic copy and must be received at the address below no later than **October 14, 2025, at 11:00am**. The sealed envelope containing each submission should include the name and address of the applicant and shall be clearly marked **“Expression of Interest –Design Review and supervision of the Construction of a Water Treatment Plant at Diamond, East Bank Demerara”**.

Interested consultants must provide information demonstrating that they possess the required qualifications and relevant experience to perform the Services outline below:

1. *At least 20 years' experience providing civil engineering services, including not less than 10 years' experience in project management and construction supervision with verifiable experience of construction safety, quality, schedule and cost best practices.*
2. *At least two (2) similar assignments in providing supervision service for the construction of Water Treatment Facilities within the past ten (10) years of which the civil works contract has a value more than US\$20M combined.*
